

Cookie policy!

MCE Nyíregyháza Kft. (Head office: 4400 Nyíregyháza Tünde u. 10/A, Registered by the Company Registry of the Regional Court of Nyíregyháza under the company registration number: 15 09 060936, tax number: 10220618-2-15), as the owner and operator of the website

www.mce-nyiregyhaza.com - hereinafter referred to as the Website – is the operator and the owner, hereinafter referred to as the Operator, and uses small text files, in other words “Cookies” - hereinafter referred to as Cookies in order to enhance and improve the experience of the user visiting the Website - hereinafter referred to as the User - and to make the browsing more efficient, as well as to make the website secure and ensure its smooth operation, in accordance with the provisions of this Policy.

In order for the Cookies placed on the Website to be able to fulfil their function, it is necessary for the user to give their consent to the use of the Cookies by clicking on the text "I ACCEPT" when visiting the Website.

I. WHAT IS A COOKIE?

A Cookie is a small text file that contains information that is stored by the Website's Operator on the hard drive of the User's computer through the internet browser running under the user's operating system. The Cookie is not suitable for running software, so no computer virus can enter the User's computer via the Cookies.

The purpose of the Cookies and they are suitable to adapt the operation of the Website to the User's needs by collecting and storing the User's preferences and information about the User's personal settings and identification (set language, font size and individual settings connected to the display of the website). During this process, the Internet browser used during each visit of the Website by the User sends the Cookies, that collect the data, to the website, which, based on this information, recognizes the User and remembers their settings later.

Based on the collected data, the User can find the information they are looking for on the Website more quickly.

II. WHAT COOKIES DOES THE WEBSITE USE?

The data of the Cookies currently used on the Website, together with a description of the purpose of their use.

Cookie's name: [GA] [Google Analytics]

The use of some of the Cookies used by the Website is absolutely necessary for the User to be able to navigate between the individual sub-sites of the Website.

- The Session Cookies are used only during the current visit, so they are automatically deleted from the User's computer when the browser is closed. The Session Cookies do not, in any case, collect any information that could be used to identify the User. Some of such Cookies store information that allows you to view certain protected content (e.g. websites visible only to the registered users).

- With the help of the Performance Cookies (Analytical Cookies; Google Analytics Cookies), the Website gathers information about its visitors in order to make the website even more transparent and easier to use.

Also, these Cookies are not suitable to identify the User.

- Using the Functional Cookies one can collect information about how (e.g. in which language) the User uses the website.

- Finally, with the help of the Statistical Cookies, we analyse how many users visit the website and how often. The data is used exclusively for statistical purposes; the users are not personally identified.

- Cookies from third parties appear when external web services are used. MCE Nyíregyháza Kft. does not supervise the saving of such Cookies.

III. HOW CAN I CHANGE OR DISABLE THE COOKIES?

If the User does not want that the Cookies, used by the Website, store information about them, they should select the option "I DO NOT ACCEPT" when visiting the Website, in which case they should declare whether they accept the use of the Cookies again when the Website is reloaded.

The User can turn off the use of the Cookies, which may result in the Website not being fully functional, and, as a result, the User will be unable to take advantage of all the functions provided by the Website.

The User can set their Internet browser in such a way that it rejects the Cookies or warns the User if a website sends Cookies to their device.

Most browsers provide the option for the User to find out about the active Cookie(s) on the devices used to browse the websites, during which they can be deleted or disabled one by one.

If the User deletes all the Cookies, the settings previously made on the website will be lost, and also the fact that the User has previously indicated that they do not allow the use of the Cookies.

IV. MODIFICATION OF THE WEBSITE'S COOKIE POLICY

The Operator is entitled to unilaterally modify this Policy. The Operator will inform the User about the changes on the Website, indicating the date of the last modification.
